


ECW-3150 SENSOR REPLACEMENT

Outlet Flow Device (1)
Outlet Body (2)
Set Screw (3)
Sensor Wire Connector (4)
Sensor Assembly (5)



INSTALLATION

- 1. Remove concealed outlet flow device (1) to expose 6mm hex opening in outlet body (2).
- 2. Cover sink drain with a paper towel. Remove and save set screw (3) from underside of spout using 1.5mm L-key (provided).
- 3. Remove outlet body (2) from spout. If needed, push the braided hose up from below the sink.
- 4. Carefully unplug the sensor wire connector (4) from the sensor assembly (5). Remove old sensor assembly (5) and clean off any sealant from outlet body (2).
- 5. Apply a small amount of di-electric grease (included) into the new sensor assembly (5) socket. Carefully plug sensor wire connector (4) into the socket. Wipe away excess grease.
- 6. Apply a thin film of silicone sealant to the bottom of the sensor assembly (5) and install onto outlet body (2).
- 7. Push outlet body into spout while gently pulling hose underneath sink down. Do not pull on the sensor cable.
- 8. If needed, use a 6mm hex L-key in the concealed outlet flow device (1) hex opening to position the outlet body (2) so the set screw (3) can be installed. Tighten set screw (3) until flush with the spout.
- 9. Re-install concealed outlet flow device (1).
